# Bar Briefs

### **Chief Justice Sarah Parker Opens Local Ethics CLE**

The Chief Justice's Commission on Professionalism presented a free CLE for members of the 28th JDB on August 4th. Speakers included judicial officials and attorneys, each providing a personal perspective on ethics and professionalism in the practice of law.

The Honorable Chief Justice of the NC Supreme Court Sarah Parker opened the gathering by detailing the responsibilities of the Commission on Professionalism, including providing "ongoing attention and assistance to ensure the practice of law remains a high calling, dedicated to the service of clients and the public good."



Melvin Wright, Executive Director of the CJCP, encouraged the local speakers to freely discuss the challenges and triumphs of practicing law. The Honorable Alan Z. Thornburg, Senior Resident Superior Court Judge, complimented the local Bar members for their ability to remain cordial. The Honorable Rebecca Knight got a laugh from the crowd of 150 when she threatened to list names of those who had been inappropriate in her courtroom.

A highlight of the afternoon was a panel discussion, led by the Honorable Harry Martin, of the many colorful characters and incidents in the history of the Buncombe County judicial community.

# **President's Perspective**



My Dad worked for Big Blue – International Business Machines or IBM. He started with IBM in the mid 1950s and worked there over 35 years. With no college education he went as far as one could go in management without a college degree. We kidded about putting our hand over our heart any time we went by an IBM facility. He was part of that company. And when there was an IBM function at his plant he was there. He took my mom too. He was dedicated to the company and he was proud of it.

IBM was good to my family. My dad was able to educate my two older brothers and he made sure I got a college education and he sent me through law school. He was able to retire at 59 years old.

My dad wasn't part of a profession like a lawyer or a doctor or a minister. But in a lot of ways he treated IBM like it was a profession and not just a job. Unlike my Dad, we are part of a profession. We are part of the legal profession. Whether it is a one man shop or a thirty five lawyer firm or a branch office of a one hundred lawyer firm, we are part of a profession.

Last month we had a rare treat in hearing Chief Justice Sarah Parker and many of our local judges talk about "professionalism." As lawyers we are sometimes inundated with talk of professionalism. Are you courteous to the court, to clients and to opposing counsel? Are you diligent in your craft and return e-mails and phone calls? Are you providing service to government, non-profits and the indigent? We in the 28<sup>th</sup> Judicial District Bar have professionalism down pat. If you attended the Chief Justice's luncheon on professionalism, you know we are the best bar in the state.

While many talk about "professionalism," few talk about being part of the "profession." Our profession takes shape on a state-wide level as the North Carolina State Bar and the North Carolina Bar Association. Locally it is the 28<sup>th</sup> Judicial District Bar. The 28<sup>th</sup> JDB acts as both the Bar and the bar association in Buncombe County. The 28<sup>th</sup> JDB puts on local, topical and inexpensive CLE programs for its members. This year it also nominated members to fill three district court positions. The 28<sup>th</sup> JDB is also the social part of the bar. It holds the Bar Luncheons, throws the Holiday Party, the Spring Picnic, the Fall cooking challenge, provides for the 28<sup>th</sup> JDB Night at the Tourists and memorializes those members that have died.

The 28<sup>th</sup> JDB has over 650 members and with the exception of the Holiday Party, it averages only about 75 members at any given luncheon, picnic or other event. Part of being a lawyer is serving one's clients, the courts and one's community. But it should also be about being part of the profession. Being a part means attending bar luncheons and other social functions. Being a part means attending the memorial service.

Being a part is attending a bar picnic with your family. You just might connect with another lawyer on a level that you couldn't inside litigation or a business deal.

At the start of the 28<sup>th</sup> JDB's new year I hope you will take time over the next several months to be a part of the profession. We all know how difficult it is to be a lawyer. But take time to reconnect with your fellow lawyers through the local bar. Take time out of your busy schedule to attend a few more bar luncheons. In September Robert Hurley of the Capital Defender's office will speak and in October Attorney General Roy Cooper will discuss the State's litigation with the TVA. Take advantage of the other social opportunities like the fall cook off next week. Come taste some great food and get to know lawyers on a different level.

I think you will find that if you do take time, you will realize that you are not alone and that you are part of something bigger than your solo practice or your firm. And you might realize that being part of a profession makes practicing law a little easier.

# **Pro Bono Case Referrals Up 37% - Case Closures Up 44 %**

As of July 2011, attorney volunteers with the local Mountain Area Volunteer Lawyer (MAVL) program accepted more pro bono cases, closed more pro bono cases, and spent more time working on pro bono cases than they did for the first six months of 2010. The total number of pro bono cases handled by MAVL volunteers in 2011 as of July was 304, which is 37% more than for the same time period in 2010. The total number of cases closed by July 2011 was up 44% from July 2010, with volunteer attorneys closing 80 more. The total number of pro bono hours devoted to pro bono cases was also up by 480, a 42% increase from last year. Thank you to all 28th JDB members for helping make this happen!

In addition to the cases handled for extended service by MAVL, private attorney volunteers also handled 232 advice cases through the MAVL Pro Bono Hotline. In this period when so many people are out of work, the 28<sup>th</sup> JDB and Pisgah Legal Services are seeking to expand capacity to serve more people in need. In September about 20 volunteer attorneys will initiate advice only service through the new Lifeline Program, providing family law advice to survivors of domestic violence.

The MAVL program is just one of a number of pro bono programs run by Pisgah Legal Services and sponsored by the 28<sup>th</sup> JDB, through the 28<sup>th</sup> JDB Pro Bono Committee (PBC). Among other activities, the PBC oversees the Self Help Center at the Courthouse, frequently sponsors local, low-cost CLEs, and recommends local attorneys and firms for pro bono service awards. The PBC recently coordinated the translation of the Self-Help divorce and custody packets into Spanish, and partnered with the NCBA 4All to promote the "ask an attorney" service day on March 4, 2011. The PBC is presently working with PLS to revise the Self-Help Center name change packets and to plan the CLE Pro Bono Training Series, including CLEs on Elder Law, Consumer Law, Family Law, and an overview of PLS's hotline program.

# **Upcoming Continuing Legal Education**

Pisgah Legal Services has teamed up with **Ellen Rose** to provide *Divorce Basics for Attorneys Helping Pro Se Clients*, a free one and a half hour CLE on Tuesday, September 27, 2011. The CLE includes an overview of the basics of how to help a client prepare the necessary documents for an absolute divorce and is specifically tailored to pro bono attorneys. The CLE is designed to bridge the gap between the large unmet need for pro bono attorneys to handle simple divorces, and the attorneys whose willingness to assist in meeting this need outweighs their substantive knowledge in this area. The program will include a discussion on the effect of obtaining an absolute divorce on spousal support, equitable distribution, a surviving spouse's share, and a surviving spouse's allowance. The CLE will focus on teaching attorneys about the pro se packet, and the presenter will also provide tips for attorneys representing divorce clients. The CLE will end with a 15 minute question and answer session with the attorney presenter.

Following the CLE, attorneys will be paired with a Pisgah Legal Services client who has been pre-screened. The attorney will assist the client in completing necessary documents for a pro se divorce.

The CLE will be held on Tuesday, September 27, 2011 at Pisgah Legal Services. Registration begins at 3:00 p.m. and the CLE will be held from 3:30 p.m. to 5:00 p.m. Participating attorneys will then have a 30 minute break and will meet with a Pisgah Legal Services client from 5:30 p.m. to 6:30 p.m. The CLE will be free to those willing to participate in the clinic.

#### **Member News**

#### A Letter of Thanks from Alan Coxie:

As both an attorney and former City of Asheville firefighter, for years now I have been fortunate to be a bridge between these two great professions. Asked by the Asheville Fire Department, the State of North Carolina, local fire departments and AB Tech; for the past five years I have been an adjunct fire instructor in the Fire Protection Technology program at AB Tech through which so many Asheville, Buncombe and other area firefighters have been trained including Capt. Jeff Bowen. Currently, I also serve as Vice Chair for the City of Asheville Civil Service Board which handles employee issues and grievances in an elected position representing all city employees.

As most of you know, Captain Jeff Bowen of Asheville Fire Department's Rescue Company Three died recently in the line of duty as a result of a heart attack while fighting the fire at 445 Biltmore Avenue. My wife Meg (also a former Asheville firefighter) and I participated in memorial events. Right after the fire, I went to Station One to speak with my friends and fellow firefighters to hear firsthand of the tragedy and to try and provide what little comfort is possible in such circumstances. I also went to Mission Hospital and visited with the injured firefighters, one of whom is a very dear friend of ours. On Friday, on behalf of the Civil Service Board, I attended the Moment of Silence ceremony. Meg and I attended the Monday evening reception and finally on Tuesday, we were honored to attend, as a part of the Asheville Fire Department, what has to be the most dramatic funeral we have ever witnessed.

In one of the largest displays of fire service support we have ever witnessed, fire departments from all over the south were in attendance Tuesday afternoon at Biltmore Baptist church. In a very touching moment, in addition to the presentation of U.S. and North Carolina flags, Jeff's children were presented Rescue Company Three fire helmets by Jeff's fire crew, one of which was his own helmet. At the end of the service, while his body was being loaded onto Engine One for the final procession, helicopters from both Mission Hospital and the State of North Carolina provided a constant flyover while the countless firefighters in attendance paid their last respects.

In order to enable Asheville firefighters to attend this service and mourn the loss of their fallen brother, not only did the various Buncombe County fire departments help out, but fire departments from as far away as Greensboro, Salisbury, Charlotte and Charleston all sent Engine Companies to stand by in Asheville Fire Stations for the last couple of days and also to work Bele Chere. As an Asheville firefighter, I have trained with most of these departments. Asheville Fire and Rescue sent fire companies to Charleston SC to help out during their recent tragic fire and line of duty deaths and so there is a very strong bond between all of these fire departments.

In the past weeks, many judges, attorneys and courthouse staff have taken me aside to both express their condolences on the loss of Captain Bowen and to express concern for Meg and I as we too, have been personally affected by recent events. Although Jeff came to the fire department after Meg and I had left, we knew him. Jeff was a very upbeat person and a real firefighter's kind of guy. While at the courthouse this week, an attorney took me aside and told me of his own very serious, life-threatening call which Jeff had responded to and in so doing, had made the difference. This is everyday stuff for Asheville
